

# **PRIVACY POLICY**

## **1. WHO?**

This Privacy Policy regulates the processing of personal data by the person responsible for processing Christie's Interieur, with registered office at Turnhoutsebaan 41A, 2970 Schilde, with company number VAT BE 0437.813.854, and as contact person Christie de Groof (info@christiesinterieur.be) .

"Christie's Interieur" respects your privacy. If you use this website or provide us with personal information through other means, you agree to this Privacy Policy. "Christie's Interieur" complies with the European Regulation 2016/679 of 27th April 2016 on the protection of personal data. She is hereby responsible for the processing of your personal data within the meaning of the General Data Protection Regulation (GDPR).

## **2. WHICH DATA?**

Personal data are collected through this website via the login form and via the order or contact form.

You can be asked to enter your name (first name - last name), e-mail address, address, VAT number, telephone number and mobile phone number.

- Your first and last name, in order to be able to address you correctly;
- Telephone number: if there is extra information or questions we can contact you quickly;
- E-mail address: to confirm your order and payment and give you an overview of your order;
- Your address: to be able to complete the delivery;

The website places some cookies. For more details, refer to the cookie policy.

## **3. WHAT ARE THE DATA USED FOR?**

The data are used to perform the contractually agreed activities. This information can be passed on to a partner in order to fulfill the delivery of the order. The user can also register via the newsletter. He/she must actively tick the newsletter box for this purpose. Permission can be withdrawn at any time. A newsletter can be sent to existing customers in case of legitimate interest, and without prior permission from the customer. An opt-out will be provided for each newsletter.

Your data will not be traded, sold, rented or passed on to third parties, except for certain selective processors who assist "Christie's Interieur" in the performance of their duties, such as the management software, the payment processing, accounting package and back-up service.

In rare cases, "Christie's Interieur" may have to disclose your personal data pursuant to a court order or in order to comply with other mandatory laws or regulations. "Christie's Interieur" will make reasonable efforts to inform you in advance in this respect, unless this is subject to legal restrictions. The personal data are stored and processed by "Christie's Interieur" for a period that is necessary in function of the purposes of the processing and in function of the contractual relationship between the "Christie's Interieur" and the user.

#### Services:

In order to provide services to our customers, we may process your personal identification data (name, (company) address, e-mail address, telephone number). We may also process other personal data that the customer shares with us for the execution of the agreement. In this context, we do not process sensitive personal data (e.g. personal data revealing your racial or ethnic origin, political opinions, religious or philosophical beliefs or trade union membership, genetic data, biometric data, data about your health or data about your sex life or sexual orientation).

The legal basis for the processing of personal data is the conclusion or performance of a contract (Article 6, §1, (b) GDPR);

We obtain these personal data directly from the data subject and/or via a third party.

We keep your personal data for as long as required to comply with our legal obligations, to provide our services correctly or because we have a legitimate interest in keeping your personal data (for longer).

Third parties with whom we collaborate for the storage and management of our data have access to this personal data (IT providers). A list of these third parties with whom we collaborate is available upon simple written request.

#### Invoicing and accounting:

For the purpose of invoicing and our accounting obligations, we may process your personal identification data (name, (company) address, e-mail address, telephone number, KBO number), financial data (bank account number, method of payment) and services provided. .

This data allows us to prepare our invoices, keep our accounts and comply with accounting obligations, including the preparation of annual accounts.

The legal basis for the processing of personal data is based on various legal obligations, such as those contained in the Code of Economic Law (art. I.1 WER, art. III.82 WER, art. III.89 WER and art. III.90 WER), the KB WV (double entry bookkeeping), the Companies and Associations Code (art. 3:1 WV) and the Income Tax Code (art. 320 WIB) (article 6, §1, (c) GDPR).

We obtain these personal data directly from the data subject and/or via a third party. For our invoicing and accounting purposes, we keep your personal data for as long as required to comply with our legal obligations, to provide our services correctly or because we have a legitimate interest in keeping your personal data (longer).

We share this personal data with our accounting firm, government services, social security agencies and banking and insurance companies. In addition, third parties with whom we collaborate for the storage and management of our data also have access to this personal data (IT providers). A list of these third parties with whom we collaborate is available upon simple written request.

#### **4. SAFETY MEASURES**

"Christie's Interieur" has developed security measures that are both technically and organizationally adapted, in order to prevent the destruction, loss, forgery, modification, unauthorized access or notification by mistake to third parties of personal data collected as well as any other unauthorized processing of these data.

By no means "Christie's Interieur" can be held liable for any direct or indirect damage resulting from the incorrect or unlawful use by a third party of your personal data. You must comply with the safety regulations at all times, for example by preventing any unauthorized access to your login and code. You are solely responsible for the use made of the website on your computer, IP address and of your identification data, as well as for the confidentiality thereof.

#### **5. RIGHTS OF THE PARTIES CONCERNED:**

You have the right to receive free of charge your personal data at any time, as well as the use made of "Christie's Interieur" with your personal data.

##### **5.1 Right to correction, deletion and limitation**

You are free to decide whether or not to communicate your personal data to "Christie's Interieur". In addition, you always have the right to request "Christie's Interieur" to correct, supplement or delete your personal data. You acknowledge that in case of refusal of communication or request for the removal of personal data, certain services may not be available. You may also request to limit the processing of your personal data.

##### **5.2 Right to opposition**

You have a right to opposition to the processing of your personal data for serious and legitimate reasons. In addition, you always have the right to oppose the use of personal data for direct marketing purposes; in that case you do not even have to give reasons.

### **5.3 Right to free data transfer**

You have the right to obtain your personal data that you have provided to "Christie's Interieur" in a structured, current and machine-readable form and / or to transfer it to other responsible persons.

### **5.4 Right to withdrawal of consent**

As far as the processing is based on your prior consent, you have the right to withdraw that permission.

### **5.5 Exercising your rights**

### **5.6 Automatic decisions and profiling**

The processing of your personal data does not include profiling and will not be subject to automated decisions by "Christie's Interieur".

### **5.7 Right to file a complaint**

This is without prejudice to a provision for a civil court.

## **WHAT ARE COOKIES?**

Cookies are small data or text files that are placed by websites onto your local computer. Such cookies can have different purposes: for example, you have technical cookies (for example with language settings), session cookies (temporary cookies) and tracking cookies (cookies that follow and track your behaviour on the website, in order to provide you with a more optimal user experience).

A cookie contains a unique code that allows you to recognize your browser during a visit to the website or to improve your user experience on repeated visits to the platform.
